We are a non-profit company fully committed to climate protection. Our permanent team is small and works cost-effectively - supported by a constantly growing group of dedicated volunteers.

Because we do not have to make a profit and do not distribute any earnings, the lion's share of donations flows directly into our climate protection projects. All donations are fully tax-deductible.




We help companies in the following ways:

With our two-way offsetting concept, we reduce and bind CO₂ emissions in Europe for maximum climate protection



Reduce CO₂ emissions

We cancel EU emission rights

Together, we buy EU emission allowances from industry and set them aside unused. In this way, we force large European CO_2 emitters to release less CO_2 .

Capture CO₂ emissions

We plant mixed forests

in Germany

Through our own reforestation efforts, we create new forests in Germany that are protected by the German Federal Forest Act.

- ✓ Climate-resilient mixed forests
- ✓ Strengthen the local ecosystem
- ✓ Long-term climate protection



The EU Emissions Trading System (ETS) is the EU's most important climate protection instrument. It is a mandatory market for emissions rights. Large industrial emitters must purchase certificates for CO₂ emissions.



- 1. Make Europe climate neutral before 2040
- 2. Become Europe's most effective CO₂ offset provider
- 3. Offset over 60 000 tonnes of CO_2 emissions by the end of 2025

How can you combine climate protection and a visit to the stadium? With the TSG climate ticket! Together with its main sponsor hep solar, the Bundesliga club is bringing an effective climate protection measure to the stands of the PreZero Arena, thereby raising awareness of climate issues among fans.



Vehicle owners in Germany receive a GHG (greenhouse gas) quota: an indirect subsidy. Fairnergy exchanges these certificates for money, which can be donated to climate protection organizations. Fairnergy collects these donations on behalf of ForTomorrow and transfers them monthly.



guud is a platform through which companies can offer their employees sustainable benefits as an in-kind, tax-free benefit. In addition to consumer goods such as food, books and sustainable clothing, employees can also donate to sustainable projects such as ForTomorrow.


